



## KEY INFORMATION DOCUMENT (“KID”) – A. GALAXY PRIVATE EQUITY FUND I

**PURPOSE:** This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**PRODUCT:** This KID is issued by FIDUSERVE ASSET MANAGEMENT LIMITED (the “Company” or “External Manager”), the Alternative Investment Fund Manager of A. GALAXY PRIVATE EQUITY FUND I (the “Compartment”) an investment compartment of A. GALAXY RAIF V.C.I.C. LTD (the “Fund”). The External Manager is authorized in Cyprus and regulated by the Cyprus Securities and Exchange Commission (herein after “CySEC”) with license number AIFM20/56/2013. CySEC is responsible for supervising the Company in relation to this KID. The Fund is an Alternative Investment Fund incorporated under the Cyprus Companies Law, Cap. 113 on 14<sup>th</sup> December 2020 with registration number HE416284 and recognised by CySEC to operate as a Registered Alternative Investment Fund (“RAIF”) in the form of a limited liability company by shares as an open-ended investment company of variable capital as provided for in Part II of the Alternative Investment Funds Law N.124(I)/2018. The Fund’s registration number is RAIF65 and the Compartment’s registration number is RAIF65\_1. The Compartment is actively managed by the External Manager and is not managed in reference to any benchmark. The Company’s contact details are:

**Term:** The Compartment may not be appropriate for investors who plan to withdraw their money within a short period of time. The life duration of the Compartment is unlimited, cannot be automatically terminated and is suitable for investments with a 5-to-10-year horizon.

**Objectives:** The Compartment’s investment objective is to generate attractive returns over the long term, by investing in a portfolio of private (non-listed) securities that are carefully selected and approved by the External Manager. There is no reference to a benchmark. The Company seeks to invest in private equity projects that have growth potential, will add value and provide dividends to its investors. The Compartment’s objective is to generate a high and rising level of income over time through investments in private companies in the online education space. Subject to this, the Compartment aims to provide capital growth over the long term and the focus will be on opportunistic investments that would allow the Compartment to achieve superior equity returns within a 5-to-10-year horizon.

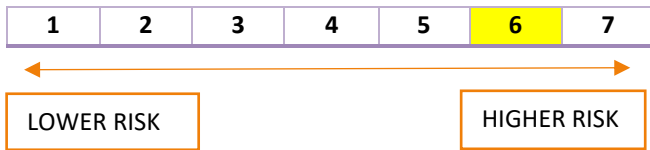
The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk Indicator:



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You cannot cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 6 out of 7 which is the second highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the capacity of the Compartment to pay you. ### WHAT HAPPENS IF A. GALAXY PRIVATE EQUITY FUND I IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

### WHAT ARE THE COSTS?

#### Costs over time

#### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

##### Recommended holding period: 5 years

The Compartment may not be appropriate for investors who plan to withdraw their money within a short period of time. It is suitable for investments with a 5-to-10-year horizon. Shares in the Compartment, however, may be redeemed on the last business day of December. Redemptions will be based on the Redemption Price calculated on the basis of the Net Asset Value per Share, as determined on the applicable Valuation Day. The redemption procedure is set out in the Offering Document. Investors wishing to have their shares redeemed by the Compartment may apply to do so by completing and sending a Redemption Request Form to the Administrator by electronic mail or facsimile. Upon subscription of shares in the Compartment, the Investors shall not be charged with any Redemption Fee.
